## CHECK IN AND MEASURING

Check in will be available on both days starting at 7:30 AM. Measuring will also be available at that time. Please check your confirmation for final order of classes and times.

## PRIZES

Ribbons for 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> place and qualifying ribbons in each height category. Mini categories may be combined for ribbons. A "leave the ribbon" draw will be available as an alternative to taking ribbons. We also offer title rosettes for ADC, AADC, and MADC titles and very special rosettes for ATChC, Bronze, Silver, Gold and Lifetime Achievement Awards.

## CLASS CHANGES

If you obtain a title on Saturday, you may move up to the next level on Sunday but you must fill out a "Class Move Up" form **on Saturday**, which will be available at the scorekeeper's table. Sorry - no same day move ups will be permitted.

**Note:** There will be no refunds, cancellations, or changes after the closing date. A dog that has entered a trial and subsequently earns a title shall be permitted to move up in that class, as long as the trial secretary is notified outside of one-week before the date of the trial. If you do not contact the trial secretary, you will not be permitted to move up on the day of the trial.

## AGILITY CLASS DESCRIPTIONS

### Standard Classes

These classes are open to all dogs, 18 months of age or older, as described within the current AAC rules.

### Special Classes

These classes are open to all dogs but are intended for dogs that are of a size or stature that limits their jumping ability. A dog may no longer compete in Regular classes after being entered at an official trial in any Special class except that they may move to Veterans.

### Veterans Classes

These classes are for dogs seven years of age or older that are currently competing in any Standard Agility Class and for dogs five years of age or older who have competed in the Specials Agility Class for a minimum of one calendar year.

### Junior Handlers

Dogs at Large is pleased to offer junior handlers classes. The AAC has expanded the Junior Handlers program to allow juniors to run in and earn qualifying scores in all classes, including games. Juniors will have veteran times and may run at a height lower than that at which the dog normally competes, and can accumulate their qualifying scores with different dogs.

### Starters Standard Class

The Starters Class is for dogs not having earned the Agility Dog of Canada (ADC) title. Dogs completing three (3) clear rounds of Starters Standard, as defined by the AAC Rules and Regulations, shall be awarded the ADC title.

### Starters Games Classes

The Starters Games Classes are for dogs that have not completed two clear rounds in that particular game scored by two different judges.

### Advanced Games Classes

The Advanced Games Classes are for dogs that have not completed three clear rounds in that particular game scored by two different judges.

## TRIAL SITE

Trial will be held outdoors, rain or shine, on a grass surface. Please note that a rope ring barrier will be used (no snow fencing).

## DIRECTIONS

The Alberta Shutzhund Association site is at the extreme SE end of the city, out in the country but within city limits.

Take Anthony Henday to the 50<sup>th</sup> Street exit south. Go south on 50<sup>th</sup> St to Ellerslie Rd. Turn left (going east) on Ellerslie Rd. and take your next right onto 34<sup>th</sup> St. Continue south on 34<sup>th</sup> St for 3 more kilometres. The Alberta Schutzhund Association is on the right hand side (you'll see CHED radio towers in the field). There is an ASA sign beside the dirt driveway with a picture of a German Shepherd on it.

## WATER

There is no running water on site. Please bring ample water for you and your dogs. Don't forget shade, sunscreen and bug spray too!

## FOOD SERVICES

Check your confirmation to see if a pop/snacks concession will be offered. There are several food services nearby on 50<sup>th</sup> Street.

## NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of the AAC, including but not limited to the following:

This event is held under AAC Rules and Regulations and is open to all dogs being at least 18 months of age, pure breed or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance.

Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specification.

No leads, collars, food, toys or any other aids or devices shall be permitted on the course at any time.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and / or children. Any exhibitor whose dogs and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and NO REFUND of fees shall be given.

**All dogs must be penned, crated or attended on leash when not in the ring.** All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disqualified and / or required to leave the show grounds and NO REFUND of fees shall be given.

Exhibitors MUST keep crate and exercise areas clean. Please clean up after yourselves and your dogs. Anyone who does not clean up after themselves or their dogs may be required to leave the show grounds and no refund will be given.

There will be no refunds, cancellations or changes after the closing date, except for bitches in season or injured dogs providing the trial secretary is informed prior to the trial date and a certificate from a veterinarian is provided.

Please be advised that a break-away tire will be used at this trial.

## General Agreement

I/We, the undersigned, agree that the host club has the right to refuse my entry for causes, which the organizing committee shall deem to be sufficient.

In consideration of the acceptance of this entry and the holding of the event and the opportunity to have the dog participate or be judged:

I/we agree to hold the organizing committee, the organization (if any) which it represents including its members, officers and directors, the Agility Association of Canada and its officers and directors, sponsors of the event, owners of premises upon which the event is held and their employees, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I/we personally assume all responsibility and liability for any such claim.

I/we further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I/we hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
